(UK Statement of Reasons):Vladimir Vladimirovich Putin is the President of the Russian Federation, carrying ultimate authority for the policy of the Russian government and Russian armed forces. In February 2022, Putin ordered Russian military forces to launch an invasion of Ukraine, undermining and threatening the territorial integrity, sovereignty or independence of Ukraine. ### Notes

- The databases interrogated (shown below) often produce A LOT of matches because their own search criteria are very loose and contain fuzzy search logic.
- Where PEP matches are found, up to 4 PEP matches only are displayed, representing those with the highest likelihood of a match. If the number of matches found is greater than the number displayed, unlikely and irrelevant matches have been excluded from the display. Don't be alarmed if there is a big difference between the number of matches found and the number displayed.
- Where Sanctions matches are found, Sanctions matches without any, or sufficient, descriptive detail have been classified as uncertified or unverified and have been excluded from display or because of duplication.
- Displayed results reflect data returned at the time of search.
- For Letting Agents and Landlords, Sanctions Matches are the only matches reportable to the OFSI under the new guidance. (You just might want to be aware if Vladimir Putin's cousin would like to rent your property).
